

# Rules of publication

Papers will be submitted in MS Word (.doc) format or OpenOffice ready for direct publication.

Authors should follow these rules of publication and instructions for editors.

## **Maximum 5 pages.**

At the beginning of the work should be included, and in this order: title, authors, affiliation and email address. Summary and key words.

## **Page setup**

Paper: width 15.5 cm and high 23.5 cm.

Margins: top 3 cm, bottom 2.5 cm, left 2 cm and right 2 cm.

Design: header: 1,5 cm; footnote: 1.25 cm; different odd and even pages.

## **Text format**

*Page header:* Times New Roman Italic 8. First page without header. Numbered pages on the left, brief title. Odd-numbered pages on the right name of the authors.

*Paged:* Times New Roman normal 9. Lower. Numbered pages on the left and odd-numbered pages on the right.

*Title:* Times New Roman 16 bold centered, spacing above 54 and later 18. Name and surname of the authors: Times New Roman 11, bold centered, spacing above 12 and subsequent 0.

*Authors address:* Times New Roman 9, normal, centered, spacing before 6 and subsequent 0.

*Titles of the headings:* lowercase. Times New Roman 10, bold, justified. First line special bleeding 0.50 cm. 12 previous spacing and subsequent 0. Subheading 1: italic Idem. Subheading 2: normal Idem.

*The rest of the text:* Times New Roman 10 normal, justified. Bleeding special frontline 0.50 cm. space between paragraphs 6. Do not use bold and replace the underscore with italics.

*Line spacing:* single in the entire document.

## **Figures and tables**

*Feet*: Times New Roman 9 normal, centered. Single line spacing. 6 And after 12 previous space. Do not use abbreviations (example Fig. 1 or tab. 1) if not the full word (example figure 1 or table 1).

Figures and tables must not be more than one page.

Figures type picture must be in JPG, BMP or GIF with a minimum resolution acceptable format that allows you to clearly see its contents.

## **References**

At the end will be included a list of references, in alphabetical order, which shall conform to the rest of the text format.

### *Books*

Last name, initial of the name. (Year of publication). Title in italics. City: Publisher.

Cheek, D. (1992). *Thinking constructively about Science, Technology, and Society education*. New York: State University of New York Press.

### *Book chapter*

Last name, initial of the name. (Year of publication). Title of the chapter. In the initial of name, surname of the editor (Ed.), title of the book in italics (pages comprising the chapter). City: Publisher.

Solomon, J. (1989). The social construction of school science. En R. Millar (Ed.), *Doing science: Images of science in science education* (pp. 126-136). New York: Falmer Press.

### *Articles*

Last name, initial of the name. (Year of publication). Title of the article. Name of the journal in italics, number, pages.
